Assessment/Forecasting

- MCIR has been updated to correctly forecast Meningococcal ACWY at 16 years of age when early doses are given. (Ref. #2106)
- The bivalent forecasting and assessment of the two-dose Janssen primary series has been updated as follows: (Ref. #2110)
 - COVID forecasting schedule was corrected fix to prevent failures for persons who have received 2 Janssen doses.
 - Series advice has been corrected to recommend a Pfizer/Moderna Booster.
- MCIR has been updated to properly record **CVX 213** via HL7 messaging. These messages were being rejected. Previously received HL7 messages with CVX 213 sent and rejected prior to today will not be processed. (Ref. #1923)

Updates

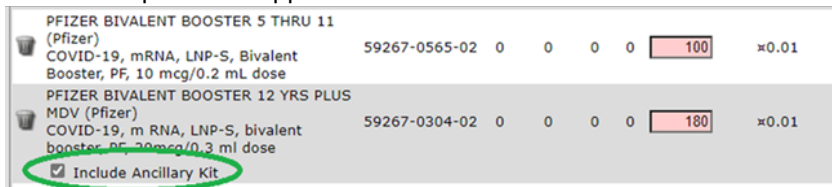
The **Online Site Re-Enrollment** feature has been enhanced as follows:

- MCIR will generate certification expiration reminder emails for site re-enrollment as follows: (Ref. #1545)
 - Providers will receive an email reminder three (3) months prior to the site's certification expiration date.
 - If providers have not completed site re-enrollment one (1) month prior to the site's certification expiration date, they will receive another email reminder.
 - If providers have not completed site re-enrollment one (1) day after the site's certification expiration date, they will receive another email reminder to complete the re-enrollment process.
 - If site re-enrollment has begun prior to the above dates, a reminder email will not be generated.
- After submitting an online site re-enrollment, providers will receive a confirmation email that the re-enrollment has been successfully submitted. (Ref. #1558)
- When a site re-enrollment has been submitted and reviewed, providers will receive either an Approved or Rejected email confirmation. (Ref. #1549)
- Pharmacies with a Corporate parent site will no longer receive an overdue "Certification Expiration Date" message on the landing page. Corporate pharmacies follow a different re-enrollment process. (Ref. #1885)

Updates (continued)

COVID Ancillary Kit Opt Out - A new feature is available for providers to opt out of receiving COVID vaccine ancillary kits. The following includes more details on this feature:

- To opt out of ancillary supplies, providers will start their outbreak order as normal by selecting the vaccines to order. Once the provider moves to the **View Order** screen, there is a new option for each vaccine to opt out of supplies.



- Each vaccine will automatically be set to receive ancillary supplies. The provider may “opt out” of receiving these supplies by unchecking the “Include Ancillary Kit” box for each vaccine line in the order. If a vaccine line does not have a checkbox, it is because ancillary opt out is not available for that particular presentation.
- Once ancillary kit options have been selected, the provider will continue the order as usual.
- Notification by email to MDHHS of ancillary opt outs will no longer be necessary.

Bug Fixes

The following reported issues have been fixed and now function properly.

- If errors are present in HL7 messages, they should appear on the HL7 viewer without producing an error. The ACK message should describe the error. (Ref. #2023)
- MCIR has been updated to remove “temp” in HEDIS output filenames. (Ref. #2185)
- LHD Non-Medical Waiver has been corrected as follows:
 - Sites should no longer receive an internal error when entering a waiver. (Ref. #2171)
 - A new column has been added to the My Waivers page. Only one non-medical waiver row is displayed when multiples of the same waiver are entered per year. (Ref. #2064)
